

Affidavit of Lensa Lelisa Tufa

BEFORE ME, the undersigned authority, this day personally appeared LENSA LELISA TUFA, who after being by me duly sworn, on oath deposes and says:

1. I am over the age of 18 and am a resident of the Region of Oromia. I have personal knowledge of the facts herein, and, if called as a witness, could testify completely thereto.
2. I suffer no legal disabilities and have personal knowledge of the facts set forth below.
3. I was enslaved by Eleanore Ajami and Crystel Khalil, hereafter referred to as Eleanore Couture, and forced to act against my will.
4. Eleanore Couture created fake email accounts and social media profiles using my name, pictures and personal information.
5. Eleanore Couture forced me to sign DMCA takedown requests, police reports and other false reports that claimed that the information posted online by This Is Lebanon was against my will, a violation of copyright and a privacy violation. None of those are true, and the documents that I signed alleging those things were signed under duress, and against my own will.
6. I was represented by the same lawyer that represented Eleanore Couture, and this representation was against my will.
7. I ask that all of the following links, videos and content be restored. They were taken down under false pretenses from Eleanore Couture, and they were often taken down because of request written in documents that I was forced to sign, under duress and against my will.
8. Known of these documents, videos or pages constitute any privacy violation or DMCA violation in relation to my rights as a copyright holder and my privacy. I desire for all of these to be restored back to their published form.
